## What is this product?

#### Туре

This product is an investment fund.

#### Term

The Fund is established for an unlimited duration, with the possibility for the Board of Directors to decide the termination of the Fund at its sole discretion.

#### Objectives

Sands Emerging Market Equities belongs to the category of Single Manager Funds.

The Funds seeks to increase the value of its assets over the long term by investing predominantly in transferable equity securities such as equities, cooperative shares or warrants on transferable equity securities issued by companies domiciled in or exercise the predominant part of their economic activity in the Emerging Markets.

The minimum asset allocation in such securities on a consolidated basis (direct and indirect investments) will be of 60% of the Fund's net assets. Moreover, the minimum Fund's investment in equity securities will be of 75% of the Fund's net assets.

**Sustainable Investment Policy** The sub-fund promotes environmental and social characteristics and qualifies as an investment product in accordance with article 8(1) of Regulation (EU) 2019/2088 on sustainability related disclosures in the financial services sector as set out in Book I. In that respect, the eligible universe is determined by criteria such as but not limited to exclusion filters, as set out in Book I. The extra-financial analysis covers at least 75% of the portfolio.

The sub-fund may invest up to 10% of its total net assets in external passive funds and/or ETF that are Art.6 under SFDR.

External funds may deviate from the Sustainability Investment Policy of the Management Company applying to direct investments. The derivative instruments are not covered by the ESG analysis.

**Relation to the Reference Portfolio** This Fund is actively managed and is compared to the MSCI Emerging Markets TR Net for performance and risk level indicator purposes. However, the reference to this index does not constitute any objective or limitation in the management and composition of the portfolio and the Fund does not restrain its universe to the index components. Therefore returns may deviate materially from the performance of the reference index.

The base currency of the Fund is USD.

Income is systematically reinvested.

Investors are able to redeem on a daily basis (on Luxembourg bank business days).

## What are the risks and what could I get in return?

#### Risks

## What happens if ABN AMRO Funds Sands Emerging Market Equities is unable to pay out?

If we are not able to pay you out what we owe you, you are not covered by any national compensation scheme. To protect you, the assets are held with a separate company, a depositary. Should we default, the depositary would liquidate the investments and distribute the proceeds to the investors. In the worst case, however, you could lose your entire investment.

#### **Costs over time**

- in the first year you would get back the amount that you invested (0% annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario,
- 10,000 USD is invested.

#### **Recommended holding period: 5 years**
