## What is this product?

### Type

This product is an investment fund.

### Term

The Fund is established for an unlimited duration, with the possibility for the Board of Directors to decide the termination of the Fund at its sole discretion.

### Objectives

Flexible Allocation Fund belongs to the category of Fund of Funds.

The Fund seeks to increase the value of its assets over the long term by implementing a diversified and actively managed portfolio of UCITS funds to seek exposure to diversified and multi-asset classes (including equities and debt instruments), with no specific restriction in the proportion in any investment category.

Allocations between asset classes will be made at the investment manager's discretion to either maintain a dynamic allocation between equities and debt instruments or to adopt opportunistic investment strategies depending on equity and debt instrument market conditions.

On an ancillary basis the Fund may invest in Money Market Instruments or Cash (up to 20% of its assets).

The Fund may invest in distressed assets up to 10% of the Fund's net assets.

This Fund is actively managed and is compared to the 35% \* (50% MSCI Europe TR Net + 40% MSCI World ex Europe TR Net + 10% MSCI EM TR Net) + 45% Bloomberg Barclays Euro Aggregate TR Index 1-10 Year + 5% Bloomberg Barclays Global High Yield Corporate EUR Hedged + 2,5% JP Morgan EMBI Global

Diversified Composite EUR Hedged + 2,5% JP Morgan CEMBI Broad Diversified Composite EUR Hedged + 10% Euribor 1 month Capitalized for performance and risk level indicator purposes. 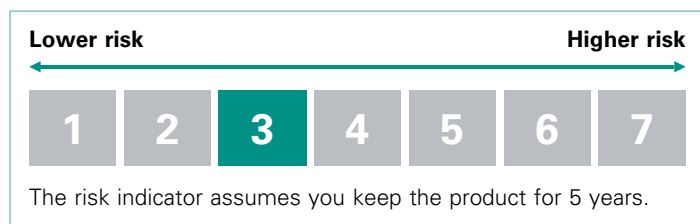

## What are the risks and what could I get in return?

### Risks



The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

### Performance scenarios

## What happens if ABN AMRO Funds Flexible Allocation Fund is unable to pay out?

If we are not able to pay you out what we owe you, you are not covered by any national compensation scheme. To protect you, the assets are held with a separate company, a depositary. Should we default, the depositary would liquidate the investments and distribute the proceeds to the investors. In the worst case, however, you could lose your entire investment.

## What are the costs?

The person advising on or selling you this product may charge you other costs. If so, this person will provide you with information about these costs and how they affect your investment.

### Costs over time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product. The amounts shown here are illustrations based on an example investment amount and different possible investment periods.

We have assumed:

- in the first year you would get back the amount that you invested (0% annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario,
- 10,000 EUR is invested.

## How long should I hold it and can I take money out early?

### Recommended holding period: 5 years

This product is designed for longer term investments; you should be prepared to stay invested for at least 5 years. Redemptions are possible on every bank business day in Luxembourg; it will take 2 working days for you to be paid.
